## REQUIREMENTS TO TAKE THE HSE TEST

### HSE TEST **(Must be an Indiana Resident and have license for at least 30 days)**

#### **Effective April 1, 2015**

**First time test takers not currently in HSE classes, must take the HSE Assessment before they are able to register for the HSE Test.  
Registration is on a first come first served basis**

17 years old Participant must provide the following:

- Exit Interview form from last Indiana school participant attended, the form must be signed by the Principal (no designee signatures accepted), Parent and Student.
- Superintendent's Recommendation Form,
- Current Indiana Driver's License or State ID or Matricula Card
- Original Birth Certificate
- Social Security Card or IRS Individual Taxpayer Identification Number (Similar to the Social Security Card)

18 years and Over Participant must provide three identifications:

- Current Indiana Driver's License, Indiana State ID or Matricula Card
- Original Birth Certificate
- Social Security Card or IRS Individual Taxpayer Identification Number (Similar to the Social Security Card)

#### **Effective January 1, 2014**

**HSE Test Fee \$90.00 IN CASH, EXACT CHANGE PLEASE**

**Registration MUST be done at least one week in advance**

**Registration is on a first come first served basis**

*If the participant has taken the HSE Test before, Indiana HSE Scores must be presented at time of registration. Copies of HSE scores can only be obtained through the Indiana State website: <https://diplomasender.com>. Please follow all instructions.*

*If the participant has taken the HSE test in another state, that out of state facility must mail official HSE scores to our facility before the participant can register for the test. Official scores can be mailed to: Hammond Adult Education, 5727 Sohl Avenue, Hammond, IN 46320.*
